Qualitative analysis of Criterion 2

After induction test and performance of students in first two internals students are identified as slow and

advance learners. Additional support is provided to slow learners in terms of mentoring, revision classes, providing notes. Advance learners encourage to participate in group discussion, class seminar, by providing reference books.

All faculty members are encouraged to practice providing practical exposure to the students by visiting fields, assignments, project work, problem solving, case studies and group discussion on relevant Topics. Science program provides practical working with the object of lab to land. The various outreach programs provide practical exposure to the problems and learnings by interactive sessions with the community members. Learner centred interactive sessions with ICT is used in teaching learning. Students are encouraged to prepare PPT, prepare project report on field visit which provides effective learnings.

The college arranges 4 unit tests, quarterly, half yearly, preparatory test as a part of CIE carrying weightage of 10%. The schedule of CIE is well planned and approved by IQAC communicated to staff and students by calendar of events, circulation of notice to the class rooms display on the notice board, WhatsApp message and display on the college website. Students are provided with tips for skilful presentation in the examination. along with question bank. After the examination papers are evaluated and the results are communicated to students on time. Students with poor performance are personally counselled for further improvement. Any doubts, quarries, clarification are taken care and resolved on the spot. The university provides schedule of examination, pattern of question paper and annual examinations which are conducted in a free and fair manner. Results are declared as per schedule. Any grievances in external assessments are resolved by university on application through college.

POs, PSOs, COs are well defined by experienced academician's and communicated to students and other stakeholders through orientation program, prospects, display on the institution's website and discuss in the classroom. POs, PSOs, COs are evaluated by students' academic performance and performance through co-curricular and extracurricular activities.

The original script on palm leaves is under study. Students are motivated to collect and study the old coins used in different stages of history. For higher research support the institution has associated itself

The college has well designed building with 5263 of construction sqmts consisting of 9 classrooms, separate staff room and principal's chamber, space for office, library, sports & gym, ICT, NSS, 4 Laboratory, store room, IQAC, well maintained sanitary blocks with sanitary pads disposal facility in Girls common room etc.

The college has recreation hall and space for cultural activities gymnasium and facility for indoor and outdoor games.

The institution is governed by government rules. The rules regulations, policies and procedures with respect to recruitment, placement, transfers, promotions, welfare facilities are governed by the department of higher education government of Chhattisgarh on the broader guidelines of UGC. The institution itself cannot have its own rules and regulations. The institution provides study leave facilities for research work, medical benefits, PF gratuity, GIS etc. as per governments rules. Self-appraisal is an annual exercise. The report is sent to higher education department. Annual accounts are maintained. However, accounts need to be audited regularly.

Qualitative analysis of Criterion 7

The college ensures safety and security of students specially girl students by providing separate common room, recreation hall, clean and hygienic sanitary block with mechanical device for usage and disposal of sanitary pads. CCTV cameras are installed at few strategic locations which monitors the safety and security of students. Need based counselling is provided to students to maintain healthy and effective learning process.

There is provision for disposal for waste materials in the college. College has a separate place for vermi culture and waste disposable pit.

College is using rain water in a pit through rain water harvesting system.

In order to promote green practices in the college it has a small herbal garden which is preserved and protected systematically and has many herbal plants. Students of NSS and Botany are maintaining this garden. College discourages students to throw plastic materials in the campus. College has prepared a pit where plastic waste is store and destroyed. Partial paperless practice is introduced in the office work. Ramps are available at few places in the college for differently abled students and other people. In order to promote various values, ethical standards and good practices college has a provision to incorporate them in their course work and through other methods.

College is celebrating various functions of national and state level and anniversaries of reputed freedom fighters and national leaders.

The two best practices apparent with intuition are Dhanvantari Herbal garden consisting of about 70 medicinal plants maintains by NSS and Botany students. Second best practice in the college is to promote leadership and discipline qualities among students through various activities.

One distinctive feature of the college is that it is located in the rural and remote area catering to the educational needs of rural, poor and reserved category students
