**Subject : RECRUITMENT OF CT/GD EXAM-2018 IN CAPFs, NIA, SSF AND AR :: OFFER OF APPOINTMENT FOR THE POST OF CONSTABLE (GENERAL DUTY) IN CRPE.**

As a result of successful qualifying all stages of examination conducted by the Staff Selection and completion of the recruitment process, you have been allotted for enlistment in CRPE. Accordingly you are provisionally selected for the appointment as Constable (General Duty) in CRPE. The post is purely temporary but likely to continue.

The Pay scale of Constable (General Duty) as per 7<sup>th</sup> CPC lies in the Pay matrix 1 and is Rs. 23100 on date. In addition to this, you will be entitled to Dearness Allowance, House Rents, Washing Allowance and other allowances as entailed to the Central Government employees, not being in time and other allowances mentioned addressed to the CRPE personnel.

The terms and conditions of appointment are as under:

- a) The post is contractual and purely temporary but likely to continue. On appointment in the post, you will be on probation for a period of two years. On successful completion of the period of probation, you will be considered for confirmation. Your services are liable to be terminated at any time by the appointing authority without assigning any reasons, in one month's notice during the initial period of 22 years in accordance with the Central Civil Services (Temporary Staff) Act, 1965.
- b) The appointing authority will have the right to transfer you to India or outside India.
- c) On appointment, you will be provided with CRPE for 1949 read with CRPE Rules, 1949 and other facilities as notified. The posting will be regulated from the date of joining CRPE. You have to follow all orders and other instructions issued to you by the appointing authority.
- d) You will be required to produce your own copy of all the necessary documents of CRPE. You will be responsible for the maintenance of these documents. As of now you have to contribute an amount equal to minimum of 10% of your Basic Pay and DA per month towards this scheme.

- l) You will not be entitled for reimbursement of any expenditure for the journey from your home town to the place of joining.
- m) In case you do not report by the stipulated date mentioned at para 4 below, the offer of appointment made to you will be deemed to have lapsed automatically and no correspondence whatsoever on the subject will be entertained.
- n) In case of OBC personnel the appointment is provisional and is subject to the community certificate being verified through the appropriate authority. If verification reveals that the claim of the candidate belonging to OBC or not belonging to the Creamy layer is false, the services shall be terminated forthwith without assigning any reason and without prejudice to such further action as may be taken under the provisions of Indian Penal Code for production of false OBC Certificate. Only valid OBC Certificate is required.
- o) Detailed particulars of next of kin with proof of age, date of birth of filling various nomination forms/documents are required.
- p) On reporting in this GC you have to produce a copy of Admn Card and OMR Sheet of the Written Examination which you qualified for selection as CT GD in CRPF.
- q) The finding/ opinion of the recruitment medical board will be valid for one year from the date of fitness to joining the service. If the candidate joins the service after validity period of recruitment medical, he/she will be examined by CRPF medical officer for any disease/ deformity that might have arisen after the recruitment medical.
- r) In case you found ineligible or suppressing facts on any ground at any time, before or after selection/ appointment, your candidature/ services will be terminated without assigning any reason.
